1. Location, length, width, depth & grade of culvert (**Square Footage of Paving**)
 2. Surface or resurfacing material
 3. Exact location of proposed installation of grating, drains or pipes
 4. Grating, drains or pipe diameter & material
 5. Storm water management control plan needed for paving over 400 sq. feet. Fee based upon review of engineer and applicant to pay.
- b. **HIGHWAY OCCUPANCY PERMIT** – (If proposed driveway abuts on Wexford Run Road)

NOTE: No installation can take place until a site inspection has been conducted and the permit issued by an Authorized Representative of the Borough. After issuance of the permit, installation shall be in strict compliance with the specifications so noted on the permit.

Driveways shall be graded for proper drainage and surfaced with asphalt, stone, brick, concrete or other approved material so as to provide for a durable surface and have storm water runoff controlled. **NO DIRT DRIVEWAYS ARE PERMITTED.**

The applicant certifies that the above information is complete and true and correct to the best of the applicant's knowledge and belief. The applicant also agrees to comply with all the provisions of Bradford Woods Ordinances, Codes and Regulations, and all other applicable laws and regulations of Allegheny County, Commonwealth of Pennsylvania, and the United States, whether or not specified in this application.

THE APPLICANT AGREES THAT IF A PERMIT IS ISSUED, THE PERMIT MAY BE REVOKED BY ADMINISTRATIVE ACTION OF BRADFORD WOODS IF COMPLIANCE WITH THE FOREGOING TWO PARAGRAPHS IS NOT ABSOLUTE.
